### TERMS & CONDITIONS:-

#### **A. E-Tendering Process:-**

- Whole bidding/tendering process will be done only online at Uttar Pradesh Government's e-procurement portal <https://etender.up.nic.in>. Bids will not be accepted manually. Digitally signed bids are to be submitted online through the e-procurement portal only. Bidders will be required to have Digital Signature Certificate (DSC) and to be registered on the e-procurement portal to be able to participate in the bidding process. Detailed instructions in this regard are available on the portal.
- Bid documents will be available for download from the date and time as mentioned.
- Required amount of e-tender fee and EMD is to be transferred online via RTGS/NEFT/ other online modes in the account of the "Executive Engineer, II<sup>nd</sup> Construction Division (E./M.), U.P. Jal Nigam, Agra" having details as below:-

No interest shall be paid on EMD.
- The e-tender will follow 2 cover system:-
  - E-tender fee and EMD (Scanned copies of their receipts are to be uploaded) and Pre-qualification and Technical bid.
  - Financial bid (BOQ)  
Each part will be opened only on completing the requirements of previous part.
- The notarized/attested copies of following documents have to be uploaded which may be verified by U.P. Jal Nigam:-
  - Character Certificate issued by District Magistrate.
  - Solvency Certificate issued by District Magistrate/Nationalized bank.
  - Registration Certificate in U.P.J.N. in required class and category.
  - GST registration certificate.

- v) Experience certificates of work of similar nature executed by the tenderer.
- vi) Authorisation Certificate from manufacturer for this tender.
6. Technical and financial e-bids have to be submitted online latest by the time and date as mentioned above.
7. The Pre qualification / Technical cum financial capacity evaluation bid shall be opened in the office of the Superintending Engineer, Construction Circle (E./M.), U.P. Jal Nigam, Agra on date and time as mentioned above in the presence of the intending tenderer's or their authorized representative.
8. Financial e-bids (BOQ) of only those bidders shall be opened who will be found eligible on scrutiny of technical cum financial capacity evaluation bid. The date and time of opening shall be intimated on the e-tendering portal.
9. Any corrigendum will only be uploaded on the e-portal. Bidders shall check the portal before submission of final bids.
10. UPJN will not be responsible for any technical issues, on the e-procurement portal, beyond its control.

**B. Other Terms and Conditions:-**

1. Only contractors/firms registered with U.P. Jal Nigam in Class-'B' and above (category-4 Electrical & Mechanical works including supply & installation of Pumping Plants) and who are authorised to quote for this tender from pump manufacturer shall be eligible to participate in tendering. The authorisation certificate must be uploaded on e-tendering portal.
2. Make of Submersible Pumping Plant shall be as per latest U.P. Jal Nigam approved make list and shall have minimum 09 nos. Submersible Pumping Plant working satisfactorily in last two year under the jurisdiction of this circle, will be accepted. The certificate of same must be uploaded along with bid document.
3. All the appurtenant materials / accessories shall be ISI marked and as per U.P. Jal Nigam approved list.
4. The rates quoted shall be inclusive of all taxes, govt. levies such as GST, labour cess and income tax.
5. U.P. Jal Nigam reserves the right to accept or reject any or all the bids without assigning any reasons and no claims shall be considered in the regard.
6. If a holiday is declared on any of the above dates, then the stipulated action will be taken on the next working day at the same time and venue.
